**TERMS AND CONDITIONS**

By entering the “TELETHON PAY BY CREDIT CARD” Promotion you are agreeing to the following terms and conditions:

**1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

**2. WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is open to all residents of Western Australia who make a donation to TELETHON during the Competition Period by calling 1300 737 507; registering their full name, address and phone number; and paying immediately using a current credit card.

2.2 Employees and their immediate families of Seven Network (Operations) Limited, Golden West Network, Channel 7 Telethon Trust and their associated agencies and companies are not eligible to enter.

**3. HOW TO ENTER**

3.1 The competition commences on Saturday 4 October 2008 at 6.00pm (Perth time) and concludes on Sunday 5 October 2008 at 8.30pm (Perth time) (“Competition Period”).

3.2 Viewers must watch TELETHON (“the Program”) on Channel Seven Perth and GWN between 6.00pm (Perth time) on Saturday 4 October and 8.30pm (Perth time) on Sunday 5 October 2008. During the Program announcements will be made pointing to the donor prize draws. Viewers who make a donation to TELETHON by calling 1300 737 507; registering their full name, address and phone number; and paying immediately using a current credit card will automatically be entered into the draw.
